RULES OF THE WAMDSAD 200 Club (The 200 Club)

1. The 200 Club commenced on 1st January 2001
2. The purpose of The 200 Club is to raise funds for WAMDSAD in all its areas of operation
3. Initially there will be no more than 200 Members of The 200 Club but this number may be reviewed by The 200 Club Administrators from time to time
4. Only members of WAMDSAD may join The 200 Club
5. The subscription amount will be £13.00 payable quarterly by Bank Standing Order on the 25th day of February, May, August and November
6. Members whose subscriptions are received within fifteen calendar days of the due date will be eligible to participate in the Draw. This will take place in the WAMDSAD Members Bar on the last Friday of the quarter month, at 9.00pm (approximately)
7. When the total number of Members of The 200 Club is less than 66, no less than 50% of the subscriptions will constitute the "Prize Fund". This will be divided proportionately as 60% first prize and 40% second and third prizes, the precise amounts to be fixed by the Administrators
8. When the total number of Members exceeds 65, prizes will be fixed in amounts of 1st prize £250 (one); 2nd prizes (two) £50 each; 3rd prizes (three) £25 each
9. Prizes will be paid out by cheque to winners, to the last known address advised to The 200 Club
10. The 200 Club, will be administered by Chairman WAMDSAD; Operations Director WAMDSAD and Treasurer WAMDSAD Enterprises Ltd. The Administrators may change from time to time as agreed by The Board of WAMDSAD Enterprises Ltd but there will always be at least two and not more than four Administrators.
11. Subscriptions paid to The 200 Club will be held in an account with Barclays Bank used solely for The 200 Club's purposes and transactions on the account will be signed by any two of the appointed Administrators. All profits earned by The 200 Club will be donated to WAMDSAD.
12. The Rules of The 200 Club may be changed from time to time. Changes will be as agreed by The Board of WAMDSAD Enterprises Ltd.
